# COMPETITION

#### **COMPETITION PERIOD**

# **COMPETITION SPECIFICS**

To participate in the Competition, a person ('Entrant') must:

• Be a registered member of Satterley Club (in accordance with 'Standard Satterley Club T&C's' - refer page 2);

and;

• Refer a purchaser to an eligible Satterley community, who proceeds to enter into a contract of sale for a lot within that community, within the competition period.

Each referred customer made by an eligible participant during the competition period will provide an additional entry.

Each Wednesday, an eligible participant from the previous competition period (closing the Tuesday prior) will be drawn at random as a winner.

At the conclusion of the seven day competition period, all existing entries will be considered void with a new competition period starting. Ie. Entries are not carried over into the following competition period.

An eligible participant may only win once within the promotion period, and will be disqualified from all other draws within the promotion period.
