## COMPETITION

## **COMPETITION PERIOD**

The Competition commences at the start of the Opening Round of the 2024 AFL Home and Away Season, Thursday 7<sup>th</sup> March 2024, and concludes at the end of Round 24 of the 2024 AFL 2024 Home and Away Season, Sunday 25<sup>th</sup> August 2024 ('Competition Period').

## **COMPETITION SPECIFICS**

To participate in the Competition, a person ('Entrant') must:

- Be a registered member of Satterley Club (in accordance with 'Standard Satterley Club T&C's' refer to page 2);
- Comply with the Conditions of Entry (refer to page 2);

and;

At the conclusion of the Competition Period, final ladder standings shown in the Competition will determine each Entrant's final ranking.

## **PRIZES**

The top three ranked Entrants on the Competition ladder ('Winners') will receive the following 'Prizes' relative to their final ladder standing:

# 1st Place - Satterley Grand Final Experience:

The first-place participant will receive the following Satterley Grand Final Experience:

Winners will be contacted by phone (after the conclusion of round 24) from Monday 26<sup>th</sup> August 2024 onwards.

Only building sales representatives who sold in a Satterley Estate during the Competition Period will be eligible for the Prizes.

In the event of a draw for any of the Prizes, the Entrant to have referred the most eligible customers to a Satterley Estate who subsequently proceed to sign an Offer & Acceptance contract during the Competition Period will be deemed the respective Winner.
